

2025 LONDON TO PARIS TERMS AND CONDITIONS

General

1. You enter London to Paris 2025 entirely at your own risk and Leukaemia Care is not liable for any injury or loss which you may suffer or incur as a result of your participation in this event unless such injury or loss is incurred as a result of Leukaemia Care's negligence.
2. By taking part in London to Paris 2025, you acknowledge that there may be conditions or circumstances which are beyond Leukaemia Care's control and which can lead to unforeseen risks. If you have any concerns or queries, please contact Leukaemia Care before agreeing to take part in this event.
3. If you are unsure of your physical ability to take part, you should take medical advice from your doctor prior to the event. It is your responsibility to ensure that you are medically fit to participate and it is extremely important that you are realistic and truthful about your capabilities and level of experience.
4. Leukaemia Care reserves the right to change, amend or alter these Terms and Conditions at any time without prior warning or permission. The latest version of these Terms and Conditions are posted on Leukaemia Care's website immediately or available upon request.

Your participation

5. You must be a minimum of 18 years of age on race day to participate in this event.
6. All charity bookings are done online at www.leukaemiacare.org.uk
7. To secure a place in London to Paris 2025 you must pay a non-refundable and non-transferable booking fee of 125.00 (inc. VAT) payable at the point of booking. The booking fee is refundable only if the event is cancelled by Leukaemia Care. The registration fee will not be refunded if you withdraw for any other reason.
8. If you wish to withdraw, you must notify Leukaemia Care on 01905 755 977 or email events@leukaemiacare.org.uk at your earliest convenience.
9. If you withdraw from the race after the London to Paris 2025 deadline (28 February 2025), when no other cyclist can be substituted, you will be liable to cover the cost of your place £1500.00.
10. By signing up to a charity place for this event, you are agreeing to raise no less than £1500 (in addition to the booking fee). This sponsorship amount is exclusive of Gift Aid.
11. If you start the London to Paris 2025 but do not cross the finish line, you will still be liable to raise the £1500.00 sponsorship amount.
12. You must have raised a minimum of £1000 by 26th March 2025 and then £500 by 16th July 2025. All remaining sponsorship must be paid to Leukaemia Care no later than 16th July 2025. If you have not raised the required minimum sponsorship amount by 16th July 2025 you are liable to cover the remaining sponsorship yourself.
13. Leukaemia Care may withdraw your charity place if, at any time, in its absolute discretion, if it considers that you are not committed to raising this sponsorship amount.
14. By taking part you consent to Leukaemia Care contacting you via phone, email, SMS, or post for any matter relating to your fundraising and participation in this

event as well as subscribing into the charities wider comms to hear more about what the charities does and how it is funded.

15. Spectators, including your supporters and family members, watch the event entirely at their own risk and Leukaemia Care shall not be liable for any injury or loss which a spectator might suffer or incur, unless such injury or loss is caused by Leukaemia Care's negligence.
16. By taking part, you confirm that you are happy for your name and any footage or photographs taken during your participation in the London to Paris 2025 to be used to publicise Leukaemia Care's work, including television broadcasts. Any photographs or video footage shared with us by you may be shared on our website, social networks and/or used in marketing materials – this may include photographs of your friends and family should you share these with us.

Fundraising

In fundraising for Leukaemia Care, you agree:

17. To submit at the end of your fundraising all used and unused paper sponsor forms.
18. Not to reproduce Leukaemia Care's name or logo without permission from the Communications Team communications@leukaemiacare.org.uk.
19. Not to collect in a public place without first obtaining the appropriate collector's licence from the local authority.
20. Not to raise funds by conducting house-to-house collection.
21. To raise all money using legal methods and complying with the advice given in the fundraising pack.
22. Not to do anything to bring Leukaemia Care's name into disrepute.
23. To keep Leukaemia Care informed of any changes to your contact details.
24. You must pass onto Leukaemia Care, all monies raised in connection with the event. You can:

Gift Aid

Commit to high standards.

- We will adhere to the Code of Fundraising Practice.
- We will monitor fundraisers, volunteers and third parties collaborating with us to raise funds, to ensure that they comply with the Code of Fundraising Practice and with this Promise.

Be clear, honest & open.

- We will tell the truth and we will not exaggerate.

Be respectful.

- We will respect your rights and privacy.
- We will not put undue pressure on you to make a gift. If you do not want to give or wish to cease giving, we will respect your decision.
- We will have a procedure for dealing with people in vulnerable circumstances and it will be available on request.
- Where the law requires, we will get your consent before we contact you to fundraise.
- If you tell us that you do not want us to contact you in a particular way we will not do so. We will work with the Telephone, Mail and Fundraising Preference Services to ensure that those who choose not to receive specific types of communication do not have to.

Be fair & reasonable.

- We will treat donors and the public fairly, showing sensitivity and adapting our approach depending on your needs.

- We will monitor and record the number of complaints we receive each year and share this data with the Fundraising Regulator on request.
